

## CREMATION PLAN

### MISTERBIANCO, SICILY

Our complete cremation plan comprises all required services, permits and logistical arrangements, for safe transfer of your loved one from any hospital on mainland Malta to our partner crematorium in Misterbianco (Catania), Sicily for cremation.

We take care of every detail to ensure smooth, caring and dignified services through till completion so families need not worry about any organisation. Families can choose to attend the cremation and return the ashes to Malta or we can arrange safe return of the ashes by courier within a few days.



Our cremation plan includes the following requirements:

- ✓ Full embalming, dressing and preparation for international travel.
- ✓ A dignified solid wood coffin suitable for air travel and cremation.
- ✓ Packaging, hermetic sealing and wrapping of the coffin for safe air travel to Sicily, all done with care and in accordance with health, airline and crematorium regulations.
- ✓ Handling of all necessary formalities, applications, permits and certifications.
- ✓ Fees payable to local health authorities and Italian consulate.
- ✓ Service of our hearse and pall bearers to convey the coffin to the airport.
- ✓ Malta airport cargo handling and security screening charges.
- ✓ Airfreight and related airline charges for air travel Malta to Catania (*max. 130kgs \**).
- ✓ Clearance and handling charges at Catania airport.
- ✓ Transfer of the coffin from the airport to the crematorium in Misterbianco.
- ✓ Services for removal of coffin packaging and cold storage at crematorium.
- ✓ Cremation fees without family attendance (*family viewing room optional*).
- ✓ Supply of a standard urn for the ashes to be collected by a family member.
- ✓ All administrative and logistical expenses involved in execution of the plan.
- ✓ Professional fees or organisation, handling and responsibility of all arrangements.

Ashes collected by the family from the crematorium:	<b>€4,500</b> <i>incl. VAT</i> <i>excl. €175 Govt. Grant **</i>
Optional courier service for return of ashes to Malta:	<b>€177</b> <i>incl. VAT</i>

\*\* *Maltese residents can apply for a government grant of €175 bringing down the standard cost to €4,325 incl. VAT.*

**OPTIONAL SERVICES:**

**Not included in the Cremation Plan**

A traditional funeral service in any church of choice can be arranged before or after the cremation service. We can also assist with organisation of a non-religious memorial wake or gathering to be held at any location of your choice, however these are not included in our standard cremation plan.



**Options and services not included in our Cremation plan:**

- Transfer from Gozo General Hospital to the mortuary on mainland Malta.
- Removal from residence or other place of death and transfer to the mortuary.
- Organisation of a funeral service in a church or any other type of religious service.
- Option to change or upgrade the coffin for viewing or funeral service in a church.
- All options in connection with a local funeral service (eg. cars, flowers, music etc...)
- Remembrance cards, order of service booklets, notices on local media etc...
- Attendance and use of a private viewing room at Misterbianco Crematorium.
- Live streaming of the cremation service.
- Upgrade of the cremation urn.
- Return of the ashes back to Malta by courier.
- Travel and logistical costs for family to accompany or attend the cremation service.
- Any other optional service not listed in the above plan.

**\*\* Airfreight costs included in our pricing covers standard coffin dimensions and weight up to 140kg. Oversized and overweight individuals may result in an additional airfreight and airport handling costs.**
